


Suicide Facts & Figures:

Utah 2020



On average, one person died by suicide every 13 hours in the state.

Almost eleven times as many people died by suicide in Utah in 2018 than in alcohol related motor vehicle accidents.

The total deaths to suicide reflected a total of 16,793 years of potential life lost (YPLL) before age 65.



Suicide cost Utah a total of **\$629,958,000** combined lifetime medical and work loss cost in 2010, or an average of **\$1,331,835 per suicide death.**

Suicide Prevention Programs and Initiatives

- The Utah Suicide Prevention Coalition (<http://utahsuicideprevention.org/>), a public-private partnership, published the Utah Suicide Prevention Plan 2017-2021 (<https://bit.ly/2tqt2kP>).
- Utah law requires: all licensed school district and charter school employees to complete 2 hours of training on youth suicide prevention within their license cycle (§ 53G-9-704); the State Board of Education to designate a school suicide prevention coordinator (§53G-9-702); and school districts to offer free parent seminars on suicide prevention (§ 53G-9-703).
- Utah law requires the Division of Substance Abuse and Mental Health (DSAMH) to designate a state suicide prevention coordinator (§ 62A-15-1101), establishes a 24/7 School Safety and Crisis Line within the University Neuropsychiatric Institute and creates the School Safety and Crisis Line Commission (§§ 53B-17-1201 to 1204).
- Utah law requires at least 2 hours of training in suicide prevention as a condition of licensure for recreational therapists (§ 58-40-302), social workers (§ 58-60-205), marriage and family therapists (§ 58-60-305), clinical mental health counselors (§ 58-60-405), and substance use disorder counselors (§ 58-60-506); and requires, as a condition of license renewal, nurse practitioners (§ 58-31b-305), physicians (§ 58-67-303, § 68-303), and physician's assistants (§ 58-70a-304) view an online suicide prevention video created by the Division of Occupational and Professional Licensing (§ 58-1-601).
- Utah law establishes and makes appropriations to the Survivors of Suicide Loss Account to provide grants for mental health treatment and family bereavement services (§ 62A-15-1502).
- HB 41 (adopted 3/22/18) directs DSAMH to establish a 24/7/365 Statewide Mental Health Crisis Line with a short code for texting and N11 number for calls and to ensure calls are answered promptly by a mental health therapist or trained crisis worker.
